However, as the contests are administered, that winner has not been announced as of this moment. Last year's award was won by Mike Athanas of Hyde Park, NY for his 2020 Raspberry Ambrosia wine. (Subsequent to this meeting, when the amateur contest results were announced, the winner of this year's Les Sperling award turned out to be Luke Capotosta of Cranston, RI for his non-vintage Strawberry/Raspberry wine.)
